



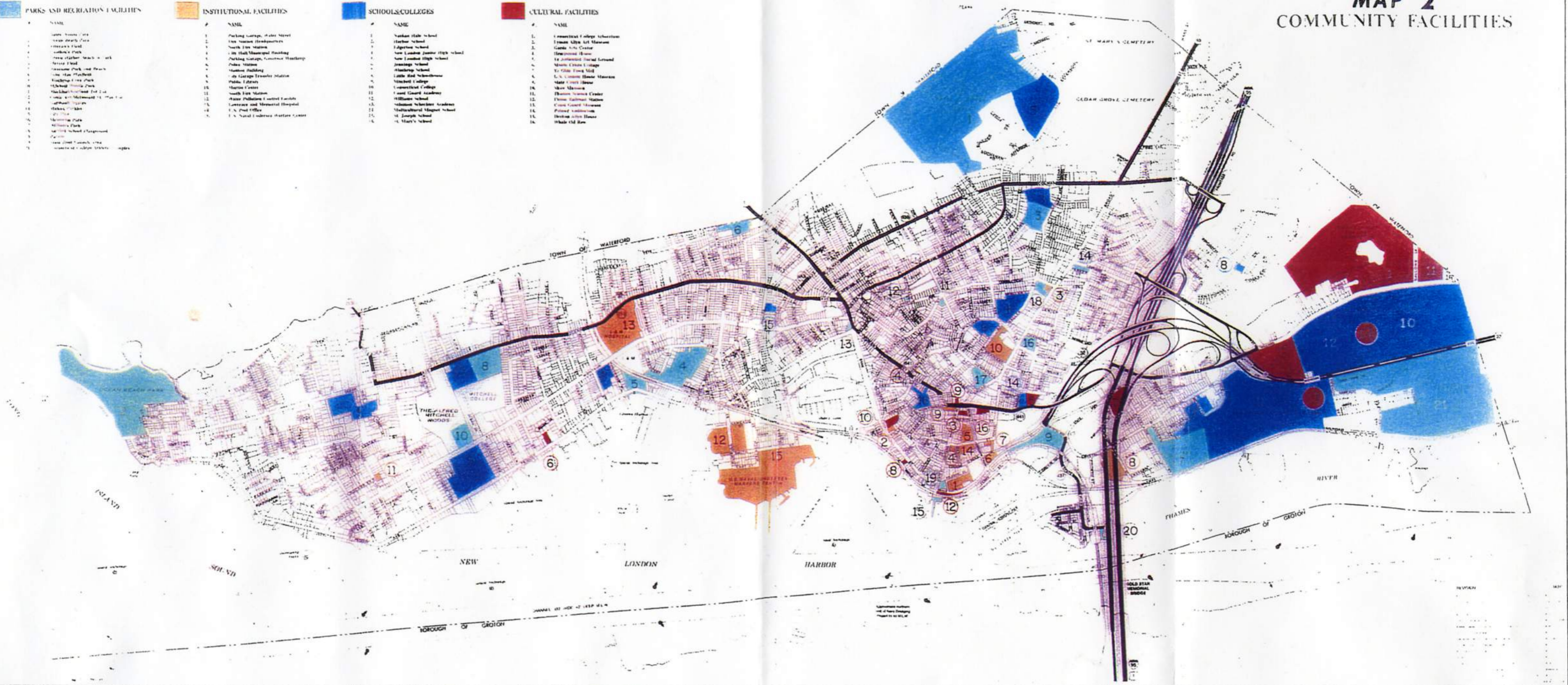


MAP 2 COMMUNITY FACILITIES
